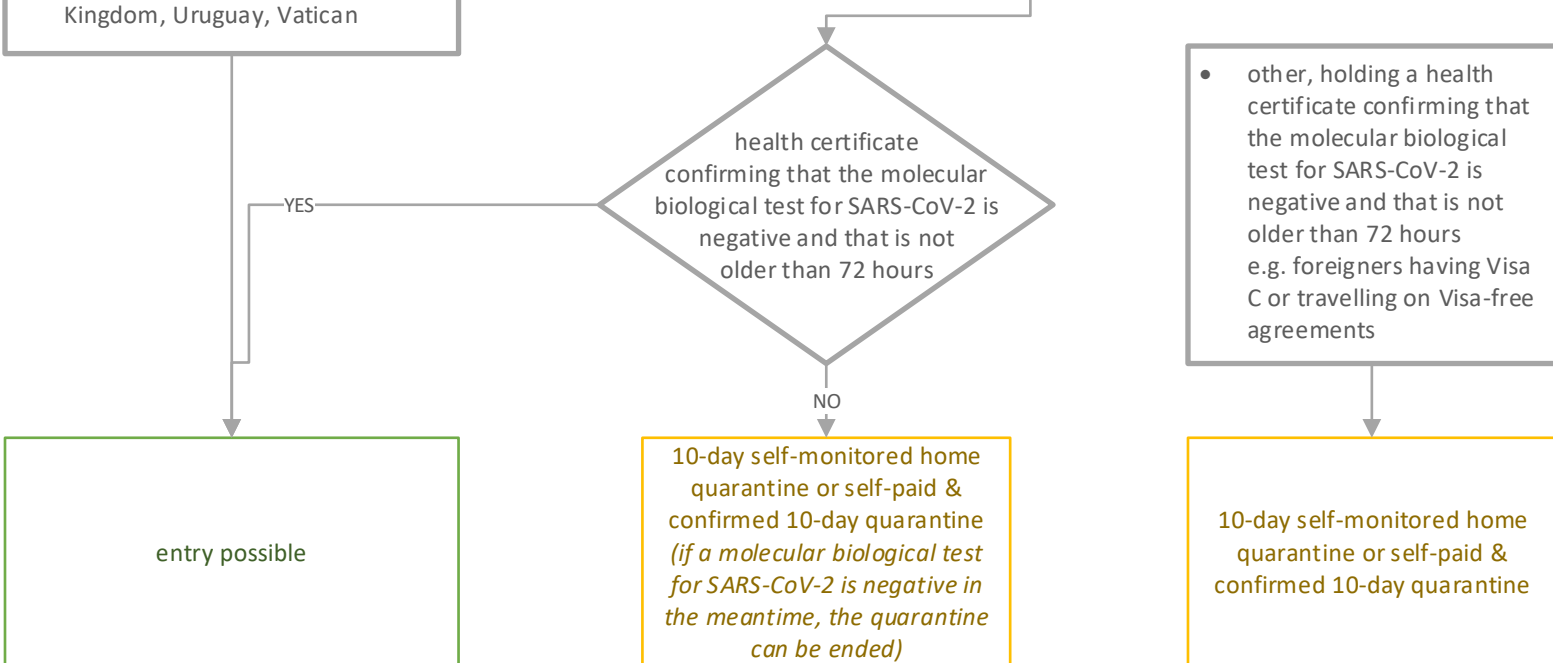

- (habitual) residents of, arriving from and only been to in the previous 10 days: Australia, Austria, Belgium, Canada, Cyprus, Czech Republic except region Prague, Denmark, Estonia, Finland, France except regions Île-de-France and Provence-Alpes-Cote d'Azur, Germany, Greece, Hungary, Ireland, Iceland, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Monaco, Netherlands, New Zealand, Norway, Poland, Portugal except regions Lisbon and Norte, Repblic Korea, San Marino, Slovakia, Slovenia, Spain – Canary Islands, Sweden, Switzerland, United Kingdom, Uruguay, Vatican

- Austrian, EU, EEA citizens and family members of these people living in the same household
- members of diplomatic missions and staff of international organizations as well as family members of these people living in the same household
- humanitarian workers, nursing and health personnel
- seasonal workers in the agricultural and forestry sector as well as tourism
- cargo-transport workers
- foreigners having Visa D issued by Austria, a documentation of the foreign police act (Fremdenpolizeigesetz), a documentation of the right of residence under the Settlement and Residence Act (Niederlassungs- und Aufenthaltsgesetz) or the Asylum Act (Asylgesetz)
- passengers travelling on business (have to provide a negative molecular biological test for SARS-CoV-2 that is not older than 72 hours)
- arriving from Bulgaria, Croatia, Czech Republic only region Prague, France only regions Île-de-France und Provence-Alpes-Cote d'Azur, Portugal only regions Lisbon and Norte, Romania, Spain mainland and Balearic Islands: molecular biological test for SARS-CoV-2 is negative and that is not older than 72 hours has to be provided upon arrival or made within 48 hours

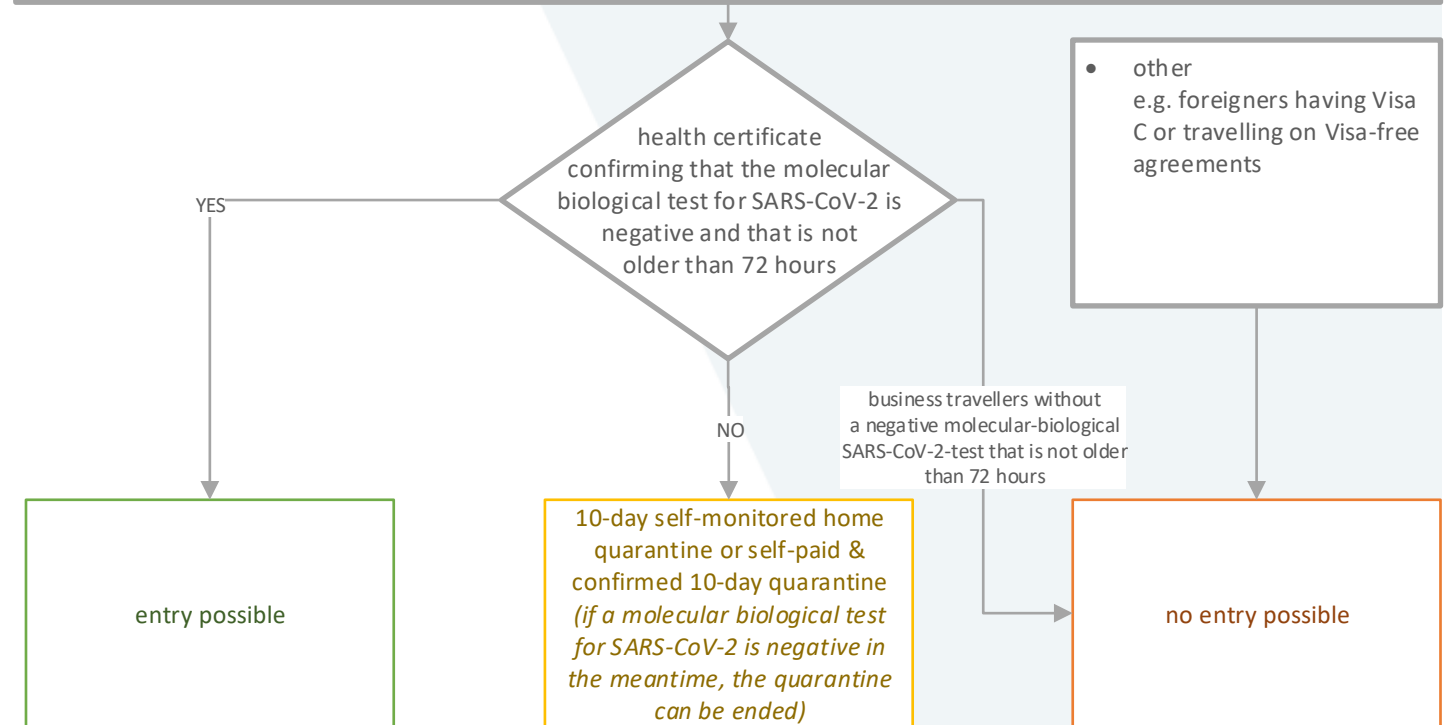
- other, holding a health certificate confirming that the molecular biological test for SARS-CoV-2 is negative and that is not older than 72 hours e.g. foreigners having Visa C or travelling on Visa-free agreements



This decree does not apply to persons if they enter Austria to maintain goods or passenger transport, to carry out a repatriation flight, for particularly considerable reasons in the family circle in individual cases, for imperative reasons of animal care in individual cases, as part of the implementation of a transfer flight, transit passengers, in the imperative interest of the Republic, Austrian citizens and persons subject to health insurance in Austria or having a promise of treatment issued by an Austrian hospital for medical reasons worth considering + 1 accompanying person, (habitual) residents of Austria re-entering after use of essential medical services abroad, commuters with a confirmation of the employer.
