



AZUL BRAZIL AIRPASS – 01AUG17*INDEF

AZUL BRAZIL AIRPASS WAS CREATED FOR FOREIGN AND BRAZILIAN CITIZENS RESIDING ABROAD WHO WISH TO TRAVEL WITHIN BRAZIL ON FLIGHTS OPERATED BY AZUL (AD).

TO PURCHASE THE AZUL BRAZIL AIRPASS, THE PASSENGER SHOULD:

- PURCHASE AN INTERNATIONAL ROUNDTRIP TICKET ON AD OR ANY OTHER AIRLINE
- AND TRAVEL COMMENCING OUTSIDE OF BRAZIL, WITH DESTINATION TO ANY CITY IN
- AZUL BRAZIL AIR PASS TICKET MUST BE ISSUED IN AD STOCK (577) IN CASE OF INTERNATIONAL TICKET WAS ISSUED BY AIRLINE NOT HAVING A MITA AGREEMENT WITH AZUL OR ANY CARRIER STOCK THAT AD HAS A MITA AGREEMENT (MULTILATERAL INTERLINE TRAFFIC AGREEMENT);
- REQUEST THE AZUL BRAZIL AIRPASS, WHICH IS ISSUED IN CONJUNCTION WITH THE INTERNATIONAL TICKET.

THE NUMBER OF OPTIONS OF DIFFERENT DESTINATIONS OR STOPOVER ALLOW UP TO 4 (FOUR) CITIES IN ECONOMY CLASS. HOWEVER, THERE MUST BE A COUPON FOR EACH PORTION OF THE TRIP - PLEASE REFER TO "STOPOVERS AND CONNECTIONS."

SEGMENTS FLOWN WITH THE AZUL AIRPASS ARE NOT ELIGIBLE TO ACCUMULATE POINTS IN TUDO AZUL PROGRAM.

RESERVATION BOOKING CLASS: "P"

TICKETING

SALES NOT PERMITTED IN BRAZIL (BR)

THE AIRPASS TICKET MUST BE ISSUED SEPARATELY AND MUST BE PURCHASED AN INTERNATIONAL ROUNDTRIP TICKET ON AD OR ANY OTHER AIRLINE THE AIRPASS MUST INCLUDE A CROSS-REFERENCE OF THE INTERNATIONAL TICKET SOLD IN CONJUNCTION WITH THE AIRPASS.

TICKETS ARE NON-ENDORSABLE/NONTRANSFERABLE

THE INTERNATIONAL TICKET NUMBER MUST BE SHOWN IN THE ENDORSEMENT/RESTRICTION BOX.

FARE CONSTRUCTIONS AND COMBINATIONS ARE NOT PERMITTED.

CHANGES

RE-BOOKING: PERMITTED FREE OF CHARGE WITHIN TKT VALIDITY

REROUTING: PERMITTED FREE OF CHARGE WITHIN TKT VALIDITY

CANCELLATION/REFUND

NO-SHOW: NON-REFUNDABLE

AFTER DEPARTURE OR PARTIALLY USED: NON-REFUNDABLE

BEFORE FIRST FLIGHT DEPARTURE: REFUNDABLE WITH PENALTY USD 150.00

BAGGAGE ALLOWANCE

BAGGAGE ALLOWANCE FOR DOMESTIC SEGMENTS COVERED BY AZUL (AD)

BRAZIL AIRPASS WILL BE THE SAME AS PERMITTED ON THE INTERNATIONAL SEGMENTS.

TO GUARANTEE THE SAME BAGGAGE ALLOWANCE FOR THE DOMESTIC FLIGHTS, A SSR XBAG-BRAZIL AIRPASS MUST BE SHOWN IN THE RESERVATION.
